- I. The Board hereby renews the Consent for Operation (CFO) & HWA of the facility issued earlier vide reference 1st cited, under 25/26 of the Water (Prevention and Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 Rules made there under; under Rule 6 of the Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016.
- II. This Combined Consent Order is issued under the **Auto Renewal System** of the Board as per the Board's Resolution and Circulars of the Board vide reference 2nd cited and as per the self-certificate submitted by **M/s. Sri Medicare Services Padkal (V), Jakranpally (M), Nizamabad District** vide reference 3rd cited. The combined CFO & HWA Order is valid for a period ending with **31st day of July, 2022**.
- III. All the conditions stipulated in combined CFO Order issued vide reference 1st cited will remain same. The Board reserves its right to review, modify, revoke conditions and vary the validity period.
- IV. In case of any false certification, non-compliance of conditions / directions and deficiency in furnishing the information by the facility, the Board can withdraw the auto renewed consent and take action under provisions of relevant Acts & Rules, including forfeiture of the Bank Guarantee submitted by the industry for Rs.10,000/- vide BG No. 12350100000011, dated 29.06.2017 with a validity period upto 28.06.2022. The industry shall extend the validity of the Bank Guarantee upto the validity period of CFO & HWA Order issued by the Board before Expiry of the above BG.

- V. This Auto Renewal Order is issued subject to the following additional conditions, in addition to the conditions stipulated by the Board vide CFO & HWA Order issued vide reference 1st cited.

After condition no 27 of Schedule – B of the CFO & HWA Order issued vide reference 1st cited, the following conditions shall be added:-

"28 The facility shall comply with the standards for Dioxins and Furans of 0.1ng/TEQ/Nm3 within two years from the date of commencement of the Bio-Medical Waste Management Rules i.e., by March, 2018. The facility shall submit time bound action plan to achieve the emission limits within 3 months time.

29 The facility shall immediately install Online Continuous Stack Emission Monitoring System (OCSEMS) for the parameters as stipulated by TSPCB in CFO & Authorisation and transmit the data real time to the servers at Telangana State Pollution Control Board and Central Pollution Control Board.

The industry should develop and maintain green belt all along the boundary of the industry and other vacant places. The industry shall take up extensive plantation under the Haritha Haram program of the State Government."

- VI. The facility shall obtain Bio-Medical Waste authorization for the facility under Bio-Medical Waste Management Rules, 2016.


- VII. Under auto renewal system, the facility shall apply at least 30 days before the expiry of the existing consent order for further renewals.
